**1. Introduction**

This agreement grants the Customer a credit for the payment of fairway dues. The Customer is also given access to an authentication certificate for the electronic reporting of declarations of fairway dues to the Swedish Maritime Administration.

**2. Undertaking**

By signing this agreement the Customer undertakes to comply with the conditions set out below during the period covered by the certificate.

**3. Conditions**

*General*

1. The basis for this agreement is the Swedish Maritime Administration's regulations on fairway dues (SJÖFS 2016:2), the Swedish Maritime Administration's Credit Policy and the Swedish Maritime Administration's Certificate Policy regarding the electronic reporting of declarations of fairway dues. See the website of the Swedish Maritime Administration for further information.



- The Customer undertakes to comply with the instructions given in the Credit Policy and the Certificate Policy in force at the time concerned.

*Payment liability*

- The Customer assumes payment liability for the fees calculated on the basis of the information reported.

*Undertakings and obligation to provide information*

- The Customer undertakes to ensure that the certificate is always held in safe-keeping and to immediately notify the Swedish Maritime Administration of any deviations that occur in this protection.
- The Customer is aware that the credit and certificate may be withdrawn or temporarily restricted if the conditions specified in the Policy are in place.
- The Customer shall also ensure that the holders of the certificate keep it in a secure manner so that unauthorised persons do not obtain access to the reporting system. A person who has access to a certificate must not allow other persons to use the certificate.
- The Customer undertakes to notify the Swedish Maritime Administration if the Customer is declared bankrupt, reaches a composition arrangement with its creditors, suspends payments or is itself subject to debt collection action and of any material other circumstances/events, for example the preparation of or the obligation to prepare a balance sheet for liquidation purposes.

*Reporting*

- The Customer undertakes to immediately notify the Swedish Maritime Administration of any error that arises when information is reported.
- The Customer is responsible for the correctness of the information reported via their own certificate.

**Responsibility and undertakings of the Swedish Maritime Administration**

- The Swedish Maritime Administration is responsible for the reporting system and undertakes to ensure, as far as possible, that it is in operation at all points in time.
- However, the Swedish Maritime Administration does not accept any form of liability for any damage or inconvenience that may arise as a result of technical faults in the system.
- The Swedish Maritime Administration is not responsible for the Customer's connection or access to the service or for the uninterrupted use of the service.
- The Swedish Maritime Administration undertakes to inform the Customer of any planned interruptions to the reporting service via the Swedish Maritime Administration's website.
